## 1. Insurance Cover Providers

- Sections 1-14 and 17-23 of your Sheilas' Wheels Travel Insurance policy are underwritten by AWP P&C SA and are administered in the UK by Allianz Global Assistance.
- Section 15 Financial failure cover is underwritten by certain underwriters at Lloyd's and provided by International Passenger Protection Limited.
- Section 16 Gadget cover is underwritten by AmTrust Europe and administered by Taurus Insurance Services Limited.

There is absolutely no cover offered by this policy whatsoever for trips which are longer than these limits per trip. This would include not insuring **you** for any part of a trip that is longer than these limits in duration.

You will not have to pay an excess if the additional premium has been paid for excess waiver and this is shown on your policy schedule.
